Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.248, dated 10.06.2016 (Annexure P-1), registered under Sections 448/452/380/34 IPC at Police Station Kherki Daula, District Gurgaon and all subsequent proceedings arising therefrom, on the basis of compromise dated 25.07.2018 (Annexure P-2).

Pursuant to order dated 06.08.2018 of this Court, the parties appeared before the trial Court/Illaqa Magistrate on 16.08.2018 to get their statements recorded. Learned Judicial Magistrate, Ist Class, Gurugram, has submitted her report vide letter bearing No.334, dated 24.08.2018 duly forwarded by learned District and Sessions Judge, Gurugram vide Endst. No.1813/C-29, dated 27.08.2018.

According to the report, learned Judicial Magistrate, Ist Class, Gurugram, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence with their free

Considering the report of learned Judicial Magistrate, Ist Class, Gurugram, dated 24.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.248, dated 10.06.2016 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
