Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.88, dated 09.06.2018 (Annexure P-1), registered under Sections 341/323/34 IPC and later on added Section 325 IPC at Police Station Lehra, District Sangrur and all subsequent proceedings arising therefrom, on the basis of compromise dated 23.07.2018 (Annexure P-2).

Pursuant to order dated 06.08.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 24.08.2018 to get their statements recorded. Learned Sub Divisional Judicial Magistrate, Moonak, has submitted her report vide letter bearing No.338, dated 30.08.2018 duly forwarded by learned District and Sessions Judge, Sangrur, vide Endst. No.5936/EB, dated 31.08.2018.

According to the report, learned Sub Divisional Judicial Magistrate, Moonak, is satisfied that compromise entered into between the

parties is genuine, voluntary, without any coercion or undue influence with

their free will.

Considering the report of learned Sub Divisional Judicial Magistrate, Moonak, dated 30.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.88, dated 09.06.2018 (Annexure P-1) (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
