Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.264, dated 23.06.2009(Annexure P-1), registered under Sections 148/149/323/506/285 IPC and 25/54/59 of the Arms Act, at Police Station Ratia, District Fatehabad and all subsequent proceedings arising therefrom, on the basis of compromise dated 04.07.2018 (Annexure P-5).

Pursuant to order dated 07.08.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 24.08.2018 to get their statements recorded. Learned Sub Divisional Judicial Magistrate, Ratia, has submitted his report vide letter bearing No.412, dated 04.09.2018 duly forwarded by learned District and Sessions Judge, Fatehabad, vide Endst. No.7617, dated 05.09.2018.

According to the report, learned Sub Divisional Judicial Magistrate, Ratia, is satisfied that compromise entered into between the

parties is genuine, voluntary, without any coercion or undue influence with their free will.

Considering the report of learned Sub Divisional Judicial Magistrate, Ratia, dated 04.09.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.264, dated 23.06.2009(Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
