Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.03, dated 06.06.2018(Annexure P-1), registered under Sections 420/406/120-B IPC and 13 of Punjab Prevention of Human Smuggling Act, 2012, at Police Station Nangal Bhur, District Pathankot and all subsequent proceedings arising therefrom, on the basis of compromise dated 02.07.2018 (Annexure P-2).

Pursuant to order dated 07.08.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 04.09.2018 to get their statements recorded. Learned Chief Judicial Magistrate, Pathankot, has submitted his report vide letter bearing No.1030, dated 04.09.2018 duly forwarded by learned District and Sessions Judge, Pathankot, vide Endst. No.2427, dated 05.09.2018.

According to the report, learned Chief Judicial Magistrate,

Pathankot, is satisfied that compromise entered into between the parties is

Considering the report of learned Chief Judicial Magistrate, Pathankot, dated 04.09.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.03, dated 06.06.2018 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
