Petitioners have filed the present petition under Section 439 Cr.P.C. for grant of regular bail in case FIR No.100, dated 07.04.2018 under Sections 406, 409, 420, 467, 468, 471, 180, 201 and 120-B IPC, registered at Police Station Mahesh Nagar, District Ambala.

Heard.

Learned counsel for the State has informed that the petitioners were arrested on 26.05.2018 and since then they are in custody. The challan has been presented before the Court.

Learned counsel for the complainant has opposed the petition by referring the allegations in the FIR.

I am of the view that the allegations alleged in the FIR are yet to be considered by the trial Court. All the offences are triable by the Magistrate. The petitioners are in custody for the last little less than four months. Since the conclusion of the trial will take time, therefore, there is no justification for further detention of the petitioners.

As such,, the present petition is allowed and the petitioners are ordered to be released on bail on their furnishing personal bonds in the sum of ₹50,000/- with one surety of the like amount each to the satisfaction of the trial Court/Duty Magistrate, subject to such conditions as imposed by the trial Court.
