The instant petition has been filed under Section 439 Cr.P.C. for grant of regular bail to the petitioner in case FIR No.108 dated 11.11.2017, under Sections 354, 506, 115, 120-B of Indian Penal Code (Section 354-A of IPC added later on), registered at Police Station Bariwala, District Shri Muktsar Sahib.

Learned counsel for the petitioner contends that the petitioner herein was taken into custody in the aforesaid FIR on 16.04.2018. It is argued that the complainant has mentioned in the FIR that the petitioner herein had entered into a contract of ₹ 8 lacs with Davinder Pal Singh, Teji Singh, Jangir Singgh and Amannpreet Singh to kill her at the behest of her father-in-law Joginder Singh. It is contended that the petitioner herein has

already appeared before the Investigating Officer and given his voice sample and said voice sample has not been matched. It is submitted that the main co-accused Joginder Singh @ Gaggi, who alleged to have given the said contract of killing, has already been granted regular bail in CRM-M-49744 of 2017. It is also contended that investigation is complete in the matter, as the challan has been presented, therefore, the petitioner is entitled to be enlarged on bail.

Per contra, learned counsel appearing on behalf of respondent-State, on instructions from the Investigating Officer, opposes the grant of regular bail to the petitioner, however, does not dispute the fact co-accused Joginder Singh @ Gaggi has already been granted regular bail.

I have heard learned counsel for the parties.

Since, the trial is likely to take some time and in view of the facts that the petitioner herein has been in custody since 16.04.2018, that the investigation is complete, as the challan has been presented and that co-accused Joginder Singh @ Gaggi has already been granted regular bail, no useful purpose would be served in keeping the petitioner behind bars. At this stage, without commenting on the merits of the case, the instant petition is allowed and the petitioner is directed to be released on regular bail on execution of adequate personal bond and surety bond to the satisfaction of concerned trial Court/Duty Magistrate.
