The present petition has been filed under Section 439 Code of Criminal Procedure for grant of regular bail to the petitioner in case FIR No.159 dated 19.6.2018 registered for the offences punishable under Sections 147, 148, 149, 307, 341, 342, 365 of Indian Penal Code (for short, "IPC"), Section 25 of Arms Act and Sections 3(2) (V) of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, 1989 at Police Station Narwana City, District Jind.

Heard.

Learned counsel for petitioner submits that the petitioner is not named in the FIR and is in custody since 23.6.2018. Nothing has to be recovered from him.

Without expressing any opinion on merits of the case and keeping in view the fact that conclusion of trial will take considerably long time, the present petition is allowed. Petitioner-Pardeep @ Gokal son of

and surety bond to the satisfaction of concerned trial Court/Chief Judicial Magistrate/Duty Magistrate, subject to following terms:-

- (a) The petitioner shall comply with the conditions mentioned in Section 437(3) Cr.P.C.
- (b) In the event of his absence on any date of hearing, the benefit of bail allowed to the petitioner shall stand withdrawn. The trial Court shall be competent to cancel his bail bond and surety bond and proceed to procure his presence in accordance with law. In that eventuality the petitioner shall have to apply for bail afresh.
- (c) He shall not leave the country without the previous permission of the Court.
