Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.125 dated 20.10.2010 (Annexure P-1) registered under Sections 326/325/324/323/506/148/149 IPC at Police Station Sadar Sunam (Sangrur), on the basis of compromise dated 04.08.2016 and 09.09.2016 (Annexures P-3 and P-4).

Pursuant to order dated 26.05.2017 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 14.08.2017 to get their statements recorded. Learned Sub Divisional Judicial Magistrate, Sunam, has submitted his report vide letter bearing No.738 dated 19.08.2017 duly forwarded by learned District and Sessions Judge, Sangrur, vide Endst. No.5546/FB, dated 21.08.2017.

According to the report, learned Sub Divisional Judicial

Magistrate, Sunam, is satisfied that compromise entered into between the

parties is genuine, voluntary, without any coercion or undue influence with

their free will.

Considering the report of learned Sub Divisional Judicial Magistrate, Sunam, dated 19.08.2017 and the fact that the compromise will bring peace and harmony in relations between the parties, FIR No.125 dated 20.10.2010 (Annexure P-1) registered under Sections 326/325/324/323/506/148/149 IPC at Police Station Sadar Sunam (Sangrur), is quashed qua petitioners namely Manwinder Singh @ Bindri, Sona Singh, Ramandeep Singh, Satnam Singh, Galwinder Singh, Sumit Kumar and Honey Kumar only, subject to payment of costs of ₹10,000/-, out of which ₹6,000/- shall be deposited with the Punjab State Legal Services Authority and ₹4,000/- with the Bar Council of Punjab and Haryana High Court.

Petition is disposed of accordingly.
