The petitioner has preferred the instant petition under Section 438 Cr.P.C., for grant of pre-arrest bail in case FIR No.81 dated 12.05.2017, registered under Sections 147, 148, 149, 302, 323, 379 (b), 120-B IPC at Police Station Siwani District Bhiwani.

Injured witness Mangal Singh attributed specific role to the petitioner. The presence of the petitioner has been established.

It has been strongly contended that the statement of said witness was recorded on 29.05.2017 whereas he was discharged from the hospital on 16.05.2017 and he was conscious much earlier.

I have heard this contention but for the grant of anticipatory bail, this ground is not sufficient as such, the instant petition stands dismissed.
