On 09.10.2017, following order was passed by a Co-ordinate Bench of this Court:-

“Through this petition under Section 438 Cr.P.C., prayer has been made for grant of anticipatory bail to the petitioner in case FIR No.94 dated 13.09.2017 registered under Sections 452, 323, 324, 148 and 149 IPC, at Police Station Mehna, District Moga.

According to the prosecution, on 12.09.2017 at about 6:00 p.m., an altercation took place between one Amanpreet Singh and Jugnu on account of change of song in a

function at the house of Harpal Singh. Thereafter, after about half an hour, co-accused Lovejeet Singh and Jugnu alongwith 4-5 unknown persons, carrying swords, baseball bats and rods again came to the venue and caused injuries to Amanpreet Singh, complainant Baltej Singh and Jagtar Singh @ Taar.

Learned counsel inter-alia contends that the petitioner is neither named in the F.I.R. nor has been attributed any role. He has been falsely implicated.

Considering over all facts and circumstances, the petitioner is directed to join investigation and would come present as and when called for and in the event of arrest, the petitioner shall be admitted to ad-interim bail on his furnishing personal and surety bonds to the satisfaction of Arresting/ Investigating Officer. The petitioner shall also abide by the conditions as specified under Section 438(2) Cr.P.C.”

As per the allegations, the occurrence took place in the evening when there was an altercation between Amanpreet Singh and Jugnu on the issue of change of song on DJ in a party. Jugnu slapped Amanpreet Singh and both of them started fighting. They were separated by the relatives. Thereafter, Lovejeet Singh @ Lovely left the programme after giving threats that he will come again along with others. After some time, Jugnu again came along with some unidentified persons duly armed with swords, baseball bats and rods and caused injuries to the complainant party as narrated in the FIR.

Learned State counsel on instructions from ASI Raj Dheer submits that though the petitioner has joined the investigation, but recovery of baseball bats is still to be effected.

Keeping in view the nature of allegations made in the FIR, I deem it appropriate to confirm the interim bail granted by this Court on 09.10.2017. However, the petitioner shall keep on joining the investigation as and when required to do so by the Investigating Officer.
