Learned counsel for respondent No.2 has filed Vakalatnama in Court today. The same is taken on record. Office to tag the same at the appropriate place.

Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.102, dated 25.08.2017 (Annexure P-1), registered under Sections 306/506/34 IPC, at Police Station Division No.3, District Police Commissionerate Ludhiana, and all subsequent proceedings arising therefrom, on the basis of compromise dated 05.09.2017 (Annexure P-2).

Pursuant to order dated 02.11.2017 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 14.11.2017 to get their statements recorded. Learned Judicial Magistrate, Ist Class, Ludhiana, has submitted his report vide letter bearing No.164, dated 18.11.2017 duly forwarded by learned District and Sessions Judge, Ludhiana, vide Endst.

No.2128/EC, dated 20.11.2017.

According to the report, learned Judicial Magistrate, Ist Class, Ludhiana, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence with their free will.

Considering the report of learned Judicial Magistrate, Ist Class, Ludhiana, dated 18.11.2017 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.102, dated 25.08.2017(Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
