Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.60, dated 31.05.2014 (Annexure P-1), registered under Sections 452/323 IPC at Police Station Nihal Singh Wala, District Moga, and all subsequent proceedings arising therefrom, on the basis of compromise/affidavit dated 11.10.2017 (Annexure P-3).

Pursuant to order dated 30.07.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 01.08.2018 to get their statements recorded. Learned Sub Divisional Judicial Magistrate, Nihal Singh Wala, has submitted her report vide letter bearing No.726, dated 10.08.2018 duly forwarded by learned District and Sessions Judge, Moga vide Endst. No.3965/EB, dated 13.08.2018.

According to the report, learned Sub Divisional Judicial Magistrate, Nihal Singh Wala, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence with their free will.

Magistrate, Nihal Singh Wala, dated 10.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.60, dated 31.05.2014 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
