Petitioner seeks benefit of regular bail pending trial in case FIR No.306, dated 04.09.2017, under Section 379-B/120-B IPC and Section 25 of the Arms Act, registered at Police Station Sadar Gohana.

Counsel for the parties have been heard.

FIR has been registered on the complaint of Sandeep S/o Jagdish. Precise allegations are that the complainant has been duped of a sum of Rs.4 lakhs approximately by certain co-accused/tantriks, namely, Raju and Roshan sons of Chander Bhan and who had taken the money on the pretext that the same would be doubled by resorting to black magic.

The present petitioner is alleged to be part of the gang and who has conspired with the aforenoticed tantriks.

Present petitioner was arrested on 24.11.2017.

Investigation in the case is complete and challan has been presented.

Trial is at the very initial stage and would take time to

conclude.

Without making any observations on merit, petitioner is held entitled to the benefit of bail.

Petitioner be enlarged on bail subject to satisfaction of the Trial Court /Duty Magistrate concerned.
