RAMENDRA JAIN, J. (ORAL)

1. Through this petition under Section 482 Cr.P.C., prayer has been made for quashing FIR No. 175 dated 16.10.2016 (Annexure P-2) registered under Sections 420 and 120-B IPC at Police Station Sadar, Ludhiana and all subsequent proceedings arising therefrom, on the basis of compromise dated 6.12.2017 (Annexure P-1), effected between the parties.

2. Vide order dated 12.7.2018, the parties were directed to appear before the trial Court/Illaq Magistrate, on dated 31.8.2018, to get their statements recorded for compromise with a direction to the trial Court/Illaq Magistrate, to furnish a report qua veracity of the compromise.

3. Consequently, parties appeared before the Judicial Magistrate Ist Class, Ludhiana and got recorded their statements qua compromise on 24.8.2018. Report from the learned Judicial Magistrate Ist Class, Ludhiana

vide letter No. 445 dated 29.8.2018 duly forwarded by the District and

Sessions Judge, Ludhiana vide letter No. 722 Dated 29.8.2018 has been received. According to the report of learned Judicial Magistrate Ist Class, Ludhiana, the parties have voluntarily entered into the compromise between themselves and have settled the matter amicably.

4. In view of the totality of the facts and circumstances and considering the fact that the compromise will bring harmony and peace in relations between the parties, this petition is allowed and the aforesaid, FIR No. 175 dated 16.10.2016 (Annexure P-2) and all subsequent proceedings arising therefrom, qua the petitioners are quashed, subject to payment of costs of Rs.10,000/-, out of which Rs.8,000/- shall be deposited with the following account:-
