RAMENDRA JAIN, J. (ORAL)

Prayer in the instant petition under Section 482 Cr.P.C.
has been made for quashing complaint case/file No.126 of
07.10.2013, titled as Som Nath vs. Rajinder Kumar & ors., under
Sections 325, 460, 504, 506, 148 & 149 IPC (P-1), pending before
learned A.S.J., Mansa, District Mansa, on the basis of compromise

(P-2) and all the subsequent proceedings arising therefrom.

2. Pursuant to order dated 17.02.2017 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 05.04.2017 to get their statements recorded. Learned Additional Sessions Judge, Mansa, has submitted his report vide letter bearing No.248, dated 24.04.2017 duly forwarded by learned District and Sessions Judge, Mansa, vide letter No.1931, dated 24.04.2017.

3. According to the report, learned Additional Sessions Judge, Mansa, is satisfied that compromise entered into between the parties is without any fear, pressure, coercion or any undue influence with their free will.

4. Considering the report of learned Additional Sessions Judge, Mansa, dated 24.04.2017 and the fact that the compromise will bring peace and harmony in relations between the parties, complaint case/file No.126 of 07.10.2013, titled as Som Nath vs. Rajinder Kumar & ors., under Sections 325, 460, 504, 506, 148 & 149 IPC (P-1), pending before learned ASJ, Mansa, District Mansa, is quashed, subject to payment of costs of ₹10,000/-, out of which ₹6,000/- shall be deposited with the Punjab State Legal Services Authority and ₹4,000/- with the Bar Council of Punjab and Haryana High Court.

5. Petition is disposed of accordingly.
