Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.107, dated 04.05.2009(Annexure P-1), registered under Sections 323/324/325/34 IPC at Police Station Sadar Sangrur, District Sangrur, and all subsequent proceedings arising therefrom, on the basis of compromise dated 14.07.2015 (Annexure P-2).

Pursuant to order dated 21.12.2017 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 10.04.2018 to get their statements recorded. Learned Judicial Magistrate, Ist Class, Sangrur, has submitted his report vide letter bearing No.796, dated 11.04.2018 duly forwarded by learned District and Sessions Judge, Sangrur, vide Endst. No.3960, dated 12.04.2018.

According to the report, learned Judicial Magistrate, Ist Class,

Sangrur, is satisfied that compromise entered into between the parties is

genuine, voluntary, without any coercion or undue influence with their free

will.

Considering the report of learned Judicial Magistrate, Ist Class, Sangrur, dated 11.04.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.107, dated 04.05.2009(Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
