ARVIND SINGH SANGWAN, J.

This order will dispose of above mentioned two petitions i.e. CRM-M-5727-2018 and CRM-M-5897-2018. In both the petitions filed under Section 482 of the Code of Criminal Procedure, 1973, petitioners are seeking quashing of FIR No. 105 dated 8.10.2013 under Sections 452, 324, 323, 148 and 149 (Section 326 IPC added later on and

Section 324, 148 and 149 IPC deleted) read with Section 34 of the Indian Penal Code, 1860 ('IPC' for short) registered at Police Station Sadar Faridkot District Faridkot, and a cross case registered vide DDR No. 36 dated 8.10.2013 under Sections 326, 323, 324 read with Section 34 IPC and all consequential proceedings arising therefrom, on the basis of compromise dated 29.1.2018 (Annexure P3).

Vide order dated 12.2.2018, a direction was given to the Illaqa Magistrate/trial Court to record the statements of the parties and submit a report regarding the genuineness of the compromise effected between the parties .

In pursuance thereof, the trial Court has submitted reports in both the cases dated 22.3.2018, (forwarded by the District and Sessions Judge, Faridkot dated 26.3.2018) after recording the statements of the parties. The trial Court has submitted that the complainants-respondents- Lakhvir Singh, Manjit Singh, Binder Singh (in CRM-M-5727-2018) and accused (in CRM-M-5897-2018) along with Harpreet Singh, Sukhdev Singh @ Baldev Singh and Veerpal Singh and complainant and accused- Jagdeep Singh and Sukhjot Singh @ Juggi (since died) (in CRM-M-5897 & 5727-2018, respectively) have appeared along with their respective counsel, who had identified them and got their statements recorded acknowledging that the compromise had been effected voluntarily, without any coercion or any undue influence. This fact is not disputed by the learned State Counsel, on instructions from Head Constable-Beant Singh that none of the petitioners is declared as proclaimed offender.

Learned counsel for the petitioners has submitted that

only one PW is examined.

As per the Full Bench judgement of this Court in **Kulwinder Singh and others vs. State of Punjab, 2007 (3) RCR (Criminal) 1052**, High Court has power under Section 482 Cr.P.C. to allow the compounding of non-compoundable offence and quash the prosecution where the High Court felt that the same was required to prevent the abuse of the process of any Court or to otherwise secure the ends of justice. This power of quashing is not confined to matrimonial disputes alone.

Perusal of allegations in the FIR reveals that the present case squarely falls in the category of cases that can be quashed by the High Court, in exercise of its inherent power under Section 482 of the Code. Keeping in view authoritative enunciation of law laid down by Hon'ble the Supreme Court of India in “**Gian Singh vs State of Punjab and another**”, **2012(4) R.C.R. (Criminal) 543** and in the light of facts and circumstances of the present case, this Court is of the considered opinion that continuation of criminal proceedings would amount to abuse of process of law and it is expedient in the interest of justice that criminal proceedings are put to an end.

Accordingly, both these petitions are allowed. FIR No. 105 dated 8.10.2013 under Sections 452, 324, 323, 148 and 149 (Section 326 IPC added later on and Section 324, 148 and 149 IPC deleted) read with Section 34 IPC registered at Police Station Sadar Faridkot District Faridkot, and the cross case registered vide DDR No. 36 dated 8.10.2013 under Sections 326, 323, 324 read with Section 34 IPC and all consequential proceedings arising therefrom, are ordered to be quashed by

way of compromise subject to payment of costs of ₹ 5,000/- each in the Office of District Legal Services Authority, Faridkot within 8 weeks from today, failing which this order shall stand recalled automatically without reference to the Court.
