The petitioner seek quashing of FIR No.151 dated 04.05.2000 under Sections 326, 324, 323, 452, 148, 149 of IPC, registered at Police Station Sadar Batala (now PS Ghanie Ke Banger) District Batala and proceedings emanating therefrom on the basis of a compromise having been effected between the parties.

Vide order dated 21.03.2018, the parties had been directed to appear before the trial Court/Illaq Magistrate so as to get their statements recorded with regard to genuineness of the compromise.

Report of learned Judicial Magistrate First Class, Batala has

been received wherein it has been reported that statements of Complainant-Gurmit Singh as well as of accused Manjinder Singh, have been recorded who have stated that they have compromised the matter and that complainant-Gurmit Singh has no objection if the FIR is quashed. It has specifically been opined by learned Judicial Magistrate First Class, Batala, that the compromise is genuine and has been effected voluntarily without there being any undue influence, threat or coercion.

In the present case, the FIR qua co-accused Jagdev Singh and Ranjit Singh had already been quashed by this Court vide order dated 14.02.2008 passed in CRM-M-50774 of 2007.

In view of the aforesaid compromise and bearing in mind the law laid down by Full Bench of this Court in 2007(3) RCR (Crl.) 1052 Kulwinder Singh and others Vs. State of Punjab, and having regard to the aforestated facts and circumstances, wherein the FIR already stands quashed qua co-accused Jagdev Singh and Ranjit Singh, the petition is allowed and FIR No.151 dated 04.05.2000 under Sections 326, 324, 323, 452, 148, 149 of IPC, registered at Police Station Sadar Batala (now PS Ghanie Ke Banger) District Batala and all the consequent proceedings arising therefrom against accused-Manjinder Singh are hereby quashed.
