By invoking Section 482 Cr.P.C., the petitioner has prayed for quashing of FIR No.175 dated 19.3.2015 for offence punishable under Sections 406, 420, 467, 468 and 471 of the Indian Penal Code registered in Police Station Karnal City Lines, District Karnal and proceedings emanating therefrom on the basis of affidavits with regard to compromise (Annexure P1) arrived at between the parties.

In the present case, the FIR was registered on the statement of Hawa Singh son of Gulab Singh. Now, dispute between the parties has been resolved by way of compromise Annexure P1.

Pursuant to order dated 22.3.2017 passed by this Court, a report has been submitted by the Judicial Magistrate Ist Class, Karnal wherein it has been reported that statements of the parties have been recorded and they have voluntarily compromised the matter.

Counsel for the State and respondent No.2 have not disputed that the parties i.e. petitioner and respondent No.2 (complainant) have arrived at a settlement with an intent to give burial to their differences.

Perusal of allegations in the FIR reveals that the present case squarely falls in the category of cases that can be quashed by the High Court, in exercise of its inherent power under Section 482 Cr.P.C. Keeping in view authoritative enunciation of law laid down by Hon'ble the Supreme Court in **Gian Singh v. State of Punjab and another**, 2012(4) R.C.R. (Criminal) 543 and in the light of facts and circumstances discussed hereinbefore, this Court is of the considered opinion that continuation of criminal proceedings would amount to abuse of process of law and it is expedient in the interest of justice that the same are put to an end.

For the foregoing reasons, the petition is allowed, FIR No.175 dated 19.3.2015 for offence punishable under Sections 406, 420, 467, 468 and 471 of the Indian Penal Code registered in Police Station Karnal City Lines, District Karnal and proceedings emanating therefrom stand quashed qua the petitioner.
