This order will dispose of the abovementioned writ petition as well as other connected writ petitions* tabulated at the foot of the order, as common questions of law and facts are involved in them, which can conveniently be decided by a common order.

In his characteristic style, Mr. Chahar has made an impassioned plea for reinstatement of his client/s as Data Entry Operators who were relieved from service in April, 2014. They have been replaced by Data Entry Operators whose names were selected and sponsored by HARTRON. Those Data Entry Operators have been working since 2014. They are not party to these petitions and, therefore, no adverse order can be passed against them. Their rights to service have in the meanwhile settled which are far superior than that of the petitioners.

It may be noticed that some of the petitioners were appointed without any public advertisement and, therefore, they cannot claim any

preferential right to continue as against names recommended by HARTRON. Thus, the principles in Hargurpratap Singh Vs. State of Punjab & others, 2007 (13) SCC 292 will not apply to these cases.

Consequently, I find no merit in these petitions and would dismiss the same.
