Learned State counsel submits that the matter in issue is rendered infructuous, as the relief prayed for in these petitions have since been granted by the State. Claim of the petitioners for promotion from Lecturers to the post of Head Master, has since been granted, and they have been promoted as such w.e.f. 10.02.2014. Affidavit of the Director, Secondary Education, Haryana dated 07.12.2017, has been filed and the same is taken on record. Copy furnished.

The factual position as set out above is not disputed by learned counsel for the petitioners. Though they submit that their claim for promotion ought to have been considered w.e.f. 15.03.2010. Be that as it may be, if the petitioners still have any grievance, they shall be at liberty to resort to measures as admissible in law.
