This writ petition under Articles 226/227 of the Constitution of India has been filed for the issuance of a writ, in the nature of mandamus directing the respondents to count the service rendered by the petitioners on the post of SPOs as qualifying service for the purpose of seniority for the post of Constables.

Learned counsel for the petitioners states that case of the petitioners is covered by judgments rendered by this Court in CWP-10376-2014, titled as “**Subhash Chand and others Vs. State of Punjab and another**” decided on 30.03.2016 (Annexure P-5), CWP-20601-2014, titled as “**Rajinder Singh and others Vs. State of Punjab and others**” decided on 08.09.2016 (Annexure P-6) and another judgment passed in CWP-1665-2017, titled as “**Budhi Singh and others Vs. State of Punjab and others**” decided on 09.08.2017 (Annexure P-7). Further, he states that at this stage he would be satisfied, if a direction is issued to respondent No.2-Director

General of Police, Punjab, Punjab Police Headquarters, Sector-9, Chandigarh to consider and decide the representation dated 23.03.2018 (Annexure P-8) in the light of Annexures P-5 to P-7.

Heard.

In view of the above, without adverting to the merits of the case, the present petition is disposed of with a direction to respondent No.2- Director General of Police, Punjab, Punjab Police Headquarters, Sector-9, Chandigarh to consider and decide the representation dated 23.03.2018 (Annexure P-8) in the light of Annexures P-5 to P-7 within six weeks from the receipt of the certified copy of the order. In case, on consideration, the competent authority reaches to the conclusion that the benefit claimed by the petitioners is admissible to them, in such eventuality, the consequential relief be allowed to them, within a period of six weeks thereafter. However, in case the competent authority feels that the relief claimed by the petitioners is not admissible to them or made out, in that case, a speaking order be passed in the matter.
