This order will dispose of CWP No.21729 of 2015, *Satyender and others v. Indira Gandhi University Meerpur, Rewari and another*, CWP No.8530 of 2017, *Reena v. Indira Gandhi University Meerpur, Rewari and another* & CWP No.190 of 2018, *Dr. Geeta Sindhu v. Indira Gandhi University Meerpur, Rewari and another*.

These petitions are disposed of with a direction to the respondent-University to place the report of Sh. Sudhir Rajpal, IAS before the Executive Council after furnishing copies of the same to each member of the Council so that a informed decision is taken on the fate of the selection process-2014 for the post of Assistant Professors in subjects for which the writ petitions have been filed. The decision be taken within a reasonable time, say preferably within four months.

The Executive Council will review its decision of 18.08.2015.

With these observations and directions, the petitions stand disposed of.
