It has been pointed out that there is no challenge to the notification under Sections 4 and 6 of the Land Acquisition Act and the only prayer made by the petitioner is to restrain the respondents from interfering in his land as mentioned in the award.

Learned counsel for the respondents has clarified this fact to state that land of the petitioner was included for acquisition. It has been specifically averred in the reply that compensation has been taken by the petitioner.

We are thus of the opinion that the instant petition needs to be dismissed but with a direction that the case of the petitioner be considered under Rehabilitation and Resettlement Policy as per his entitlement.
