**AJAY KUMAR MITTAL, J. (Oral)**

1. The prayer in this petition filed under Articles 226/227 of the Constitution of India is for issuance of a writ in the nature of mandamus directing the respondents (i) to allot plot measuring 500 sq. yards under oustee category in compliance to the order dated 23.09.2013 (**Annexure P-4**) passed by respondent No.3 in compliance to the order dated 20.05.2013 (**Annexure P-3**) passed by this Court, in a time bound manner and; (ii) to put the name and application of the petitioner in the draw of lots to be held on 20.09.2017 (**Annexure P-5**) for the purpose of allotment of plot measuring 500 sq. yards under oustee category of Sector 76-80, SAS, Nagar Mohali, in strict compliance to the order dated 23.09.2013 (**Annexure P-4**) and accordingly, to allot him the plot on preferential basis.

2. Learned counsel for respondents No.2 & 3-GMADA has filed short reply by way of an affidavit dated 27.02.2018 of Smt. Pooja

Sayal Grewal, Estate Officer, Greater Mohali Area Development Authority, PUDA Bhawan, Sector 62, SAS Nagar, on behalf of respondents No.2 & 3 in Court today. The same is taken on record, subject to all just exceptions. It has been stated in the aforesaid affidavit that the petitioner has made a prayer to allot a plot measuring 500 sq. yards under the oustee category in compliance of the order dated 23.09.2013 (**Annexure P-4**) passed by the Estate Officer, GMADA, in compliance of order dated 20.05.2013 (**Annexure P-3**) passed by this Court and to put his name and application in the draw of lots to be held on 20.09.2017 for the purpose of allotment of plot measuring 500 sq. yards of Sector 76-80, SAS Nagar. In that regard, it has been stated therein that the name of the petitioner has already been considered in the draw of lots held on 26.10.2017, when he remained successful for allotment of 500 sq. yards plot under the oustee category against R. No.348 and he has been earmarked Plot no.1849, Sector 80, SAS Nagar.

3. In view of the aforesaid affidavit, it was not disputed by learned counsel for the parties that the necessary relief has been granted to the petitioner and the present writ petition has been rendered infructuous and prayer was made to dispose of the petition as such.

4. Ordered accordingly.
