Present appeal has been filed by the claimant under Section 173 of the Motor Vehicles Act, 1988 (*for short 'Act'*) against the impugned Award dated 17.11.2014, passed by learned Motor Accident Claims Tribunal, Panchkula (*for short 'Tribunal'*) for enhancement of compensation on account of death of Smt. Bimla Sharma (*for short 'deceased'*).

Today, the matter has been listed before the National Lok Adalat.

Learned Counsel for respondent No.2/Insurance Company has offered to grant Rs. 60,000/- (Sixty Thousand Only) over and above the amount, granted by learned M.A.C.T., Panchkula. This amount is acceptable to the appellant as full and final settlement. Statements of learned Counsel for the parties to this effect have been recorded separately.

In view of the above amicable settlement between the parties, we direct respondent No.2/Insurance Company to deposit the aforesaid enhanced amount by way of cheque or demand draft in the name of the appellant with the Office of Lok Adalat of the High Court within eight weeks from today and the same be handed over to him against proper

receipt and identification, failing which, the amount would carry interest at the rate of 9% per annum from the date of settlement till its realization.

FAO stands disposed off.
