The petitioner, Niranjan @ Nainu, is a convict undergoing one year sentence w.e.f. 06.07.2017 for offence punishable under Section 25 of the Arms Act, 1959 for possessing unlicensed .32 bore revolver in case FIR No.534 dated 15.10.2009 under Section 25 of the Arms Act, registered with Police Station Civil Lines, Rohtak.

It is stated that the petitioner has undergone almost 08 months of the sentence and the prayer is for grant of leave from jail for attending the marriage ceremony of his cousin, fixed for 18/19.02.2018.

Upon notice, reply by way of affidavit dated 16.02.2018 of Shri Tej Singh, Deputy Superintendent of Police, District Jail, Rohtak, has been filed in Court today, which is taken on record. In the reply, para 10 reads as

under:-

“ That this office has received the enquiry report in the above matter, true translated copy of which is annexed as Annexure R-2. Sarpanch of the village certified that marriage of cousin brother of petitioner (Son of his Bua's daughter) will take place on 18.02.2018 and 19.02.2018 and there is no one else in the family, other than the petitioner who can perform Bhat ceremony. ”

On a pointed query, Shri Satbir Singh, Jail Warden, District Jail, Rohtak has conveyed that the conduct of the petitioner during the period of custody has been peaceful and good.

Keeping in view the aforesaid circumstances, the present petition is allowed and it is ordered that the petitioner would be released on temporary bail to the satisfaction of the Superintendent, District Jail, Rohtak w.e.f. the morning of 18.02.2018 till the morning of 20.02.2018. The petitioner shall surrender before the Jail Authorities by 11.00 a.m. sharp on 20.02.2018.

Copy of the order be given **dasti** on payment of usual charges.
