This order shall dispose of 22 writ petitions bearing CWP
Nos.626, 1683, 628, 633, 937, 1002, 1949, 5430, 5476, 5914, 5953, 5959,

5977, 5985, 5988, 5993, 5997, 5999, 6783, 6784, 6848 & 6890 of 2018 as the issue involved in all these cases is common.

At the outset, learned counsel for the State has submitted that though in some of the writ petitions notice of motion has not been issued but he has instructions from the Transport Commissioner, Haryana to withdraw the impugned order passed in all these cases for the purpose of reconsidering the application of the petitioner(s). It is also submitted that the respondents have taken a decision that they would not raise any objection regarding deposit of ₹1 lac by the petitioner(s) but other issues would be considered and decided.

In view of the aforesaid facts and circumstances, all the petitions are hereby disposed of with a direction to the Transport Commissioner, Haryana to reconsider the application of the petitioner(s) and decide the same expeditiously and preferably within a period of 15 days from the date of receipt of certified copy of this order.
