terms of the judgment of even date passed in RFA-1006-2010 titled as State of
Punjab & Ors. vs. Usha Rani (II). In the said bunch of cases which also
pertained to the acquisition of Ranjit Sagar Dam, 12 notifications including the
present notification as also the cross-objections filed by the land-owners were
duly considered. The present cross-objections could not be listed on earlier
occasion by the office. Accordingly, the cross-objections are also being
disposed of in same terms as per the main judgment (cited supra).
