Through this application, a prayer has been made for review of the order dated 12.11.2018 passed by this Court as sought by the applicants-appellants.

Heard.

Since recovery rights given to respondent No.1-Insurance Company against petitioner No.2-Rajpal @ Ramphal, were cancelled by this Court vide judgment dated 01.05.2018, therefore, it is apparent that in order dated 12.11.2018, it has wrongly been observed that a sum of Rs.25,000/- deposited by the applicants/appellants cannot be disbursed to them. Consequently, the applicants-appellant are definitely entitled for refund the amount of Rs.25,000/- deposited by them with the registry at the time of filing of appeal i.e. FAO No.5588 of 2015 titled as "Inderjeet and another Vs. The Bharti AXA General Insurance Company Ltd. and others".

Accordingly, registry is directed to disburse the amount of Rs.25,000/- deposited by the applicants/appellants against proper receipt and identification in accordance with law.
