Without going into the merits of the claim of the petitioners, this Court directs the petitioners to make a fresh representation before the Chief Engineer (Irrigation), Water Resources Department, Siwan within a period of four weeks from today, who on receipt of the same shall dispose it off by reasoned order within a period of eight weeks thereafter.

With the aforesaid observation / direction, this petition stands disposed off.
