16.08.2017 passed in ***L.P.A. No. 756 of 2015 (The State of***



Bihar & ors. vs. Ram Ashis Tiwari & Anr.).

Per contra, the learned counsel for the respondents submits that the respondent no. 5 shall examine the case of the petitioners and take a final decision.
