3 22-11-2019 The petitioners seek quashing of the order dated 10.12.2014 passed by the learned Judicial Magistrate 1st Class, Biharsharif, Nalanda in connection with Complaint Case No. 919 C of 2014, whereby cognizance has been taken under Sections 323, 420, 465, 467, 468, 471 and 504/34 of the Indian Penal Code.
