3 21-08-2019 Both the writ petitions involve similar question and as such they have been heard together and are being disposed of by this common order.

Earlier the writ court has considered the similar issue and allowed the writ petition, CWJC No. 6139 of 2007 on 31.3.2011 and the Letters Patent Appeal No. 756 of 2015 against aforesaid order of the writ court was dismissed by the LPA Court on 16.08.2017 and the order of the writ court was



approved.

Considering the aforesaid, both the writ petitions are allowed in terms of the order dated 31.3.2011 passed in CWJC No. 6139 of 2007 which was approved by order dated 16.08.2017 in LPA No. 756 of 2015.

The respondents are directed to take appropriate decision granting similar benefits to these petitioners also within a maximum period of three months from the date of receipt/production of a copy of this order.

With the aforesaid, both the writ petitions stand allowed and disposed of.
