learned counsel for the State.

In this case, the petitioners are seeking anticipatory
bail in connection with Complaint Case No. 2938 of 2017, Trial
No. 2290 of 2018, registered for the offence under Section 498-
A of the Indian Penal Code.

The petitioner no.1 is brother-in-law, petitioner



no.2 is father-in-law, petitioner no.3 is mother-in-law, petitioner no.4 is sister-in-law and petitioner no.5 is *Bhabhi* of the complainant.

Looking to the relationship of the petitioners with the complainant, let the above-named petitioners be released on anticipatory bail in the event of their arrest or surrender before the learned Court below within a period of six weeks from today, on furnishing bail bonds of Rs.10,000/- (Rupees Ten Thousand Only) each with two sureties of the like amount each to the satisfaction of the A.C.J.M.-IX, Gopalganj, in connection with Complaint Case No. 2938 of 2017, Trial No. 2290 of 2018, subject to the condition as laid down under Section 438(2) of the Code of Criminal Procedure.
