ORAL ORDER

3 09-05-2019 Heard learned counsel for the petitioner, learned
counsel for the State and learned counsel appearing on behalf of
the Accountant General, Bihar, Patna.

The writ application being C.W.J.C. No. 7751 of 2019
was disposed of on 18.04.2019.

Learned counsel for the petitioner has filed a
supplementary affidavit stating therein that due to inadvertence,



the place from where the petitioner retired on 28.02.2017 as Assistant Engineer is from the Sub Division Office, Baisi, Rural Works Department, Government of Bihar, Patna and again due to typographical error in the writ petition, the Department of respondent no. 2 to 5 would accordingly be Rural Works Department, Government of Bihar, Patna and not Road Construction Department, Government of Bihar, Patna. He further submits that as a consequence, the direction to file a representation would be before the respondent no. 3, the Engineer-In-Chief, Rural Works Department, Government of Bihar, Patna and not the Department of Road Construction, Government of Bihar, Patna.

Considering the statement made in the supplementary affidavit filed by the petitioner, the name of the department of respondent no. 2 to 5 would be read as Rural Works Department, Government of Bihar, Patna and the department from which the petitioner retired would be Rural Works Department, Government of Bihar, Patna instead of Road Construction Department, Government of Bihar, Patna as also the direction to file a representation would be before the respondent no. 3, the Engineer In-Chief, Rural Works Department, Government of Bihar, Patna.



The order dated 18.04.2019 passed in C.W.J.C. No.
7751 of 2019 is modified to the extent indicated above.
