2 16-05-2019 Heard learned counsel for the petitioner and learned
counsel for the State.

The present application has been filed for
modification of the order dated 26.04.2018 passed in Cr. Misc.
No. 25451 of 2018, by which the petitioner was granted
anticipatory bail in connection with Ghorasaahan (Jitna) P.S.
Case No. 581 of 2017, pending in the court of learned S.D.J.M.
Sikrahana at Dhaka, East Champaran and the petitioner was
directed to surrender in the court below within a period of six
weeks and furnish bail bond.

Learned counsel for the petitioner submits that due to



some unavoidable reasons the petitioner could not surrender in the court below well within time. It is prayed on behalf of the learned counsel for the petitioner that name of petitioner may be corrected in the order dated 26.04.2018 passed in Cr. Misc. No. 25451 of 2018 as 'Saroj Ray @ Saroj Kumar Ray @ Akhilesh Kumar' in place of 'Saroj Ray @ Saroj Kumar Ray'. It is further submitted that further time may be extended so that the petitioner could surrender in the court below and furnish bail bond.

Considering the submissions made on behalf of learned counsel for the petitioner and the grounds mentioned in the modification application, the name of the petitioner in the order dated 26.04.2018 passed in Cr. Misc. No. 25451 of 2018 be read as 'Saroj Ray @ Saroj Kumar Ray @ Akhilesh Kumar' in place of 'Saroj Ray @ Saroj Kumar Ray' and the period of surrender of the petitioner in the court below is extended for a further period of six weeks from the date of receipt/production of a copy of this order. The rest of the conditions stipulated in the order will be same.

The order dated 26.04.2018 passed in Cr. Misc. No. 25451 of 2018, is modified to the extent as indicated above.
