No. 22600 of 2019 in respect of petitioner no. 2 as, it has been stated that though correct name of father of petitioner no. 2 is late Ramayan Singh, in the petition it was incorrectly typed as Motilal Singh. Because of the said discrepancy, in the order, dated 10.04.2019, passed in Cr. Misc. No. 22600 of 2019 father's name of the petitioner no. 2 has been described as Motilal Singh, which ought to have been late



Ramayan Singh, as stated in the application.
