2. Learned GA-7 for the State and learned counsel for the Union of India have assisted the Court.

3. Second supplementary show cause has been filed on behalf of the State in which stand has been taken that out 76 petitioners, in compliance of the order dated 15.12.2016 passed in CWJC No.11305 of 2016, scholarship money have been paid to 73 petitioners, but with regard to three, their cases have not been found to be eligible for payment due to various reasons, which have been enumerated in the affidavit.

4. Learned counsel for the State submitted that as nobody is appearing on behalf of the petitioner, copy of supplementary show cause filed today has not been served upon him.

5. Having gone through the pleadings and materials on record, the Court finds that order of the writ Court has been complied with.
