3 17-04-2019 Heard the learned counsel for the parties.

The learned counsel for the petitioners submits that the petitioners would be satisfied in case they are granted liberty to file a representation before the respondent no. 9 and the respondent no. 9 may be directed to dispose off the representation of the petitioners within a specified time frame.
