The present appeals have been preferred against the



judgment and order dated 23<sup>rd</sup> of July, 2018 passed by a learned Single Judge of this Court in C.W.J.C. No. 8005 of 2009.

Learned counsel states that since the private respondents stand appointed and have been working to the satisfaction of the authorities from the year 1999, the employer does not want to file any appeal.

We find that the appellants in both these appeals have filed their applications on affidavit seeking withdrawal of the appeals. The said affidavits are dated 8.4.2019 (In L.P.A. No. 1192 of 2018) and 4.4.2019 (In L.P.A. No. 1200 of 2018).

The applications seeking withdrawal of the appeals stand allowed, and in consequence thereof, both the appeals stand dismissed as withdrawn.
