2 17-05-2019 The present petition has been filed for modifying the order dated 19.02.2019 passed in CWJC No. 10032 of 2009 inasmuch as the said case is the lead case and all the directions have been passed from time to time in the said case, including the one which is sought to be modified. The present case is said to have been an analogous case of the aforesaid case. This Court, vide order dated 19.2.2019 had directed that since certain Universities are not interested in receiving the report despite
