9. 04-02-2019 In compliance with order dated 02-11-2018, report from the office of Superintendent of Police, Madhepura has been received, vide letter no. 05/G.S. dated 05-01-2019 (flag 'y'). The report makes it clear that the appellant no. 1 Bhajan Yadav {in Cr.Appeal (DB) No. 1076 of 2010} and sole appellant Chandeshwari Yadav {in Cr.Appeal (DB) No. 1034 of 2010} died on 09-09-2018 and 09-01-2013 respectively.
