for the State.

2. The petitioner apprehends his arrest for the offences alleged under Sections 341, 149, 147, 148, 323, 324, 308, 379 and 354 of the Indian Penal Code registered in connection with Govindpur P.S. Case No. 212 of 2018.

3. It is submitted that the petitioner has been falsely implicated and the FIR is against as many as 12 named persons. The specific accusation of assault with *Saif* (sharp cutting weapon) is upon co-accused Dinesh Prasad Yadav and no injury has been caused by the alleged action of the petitioner, who claims clean antecedents.

4. Be that as it may, in the event of the petitioner's arrest or surrender before the court below within six weeks from the date of communication of this order, let the above named petitioner be released on bail on furnishing bail bond of Rs.10,000/- (ten thousand) with two sureties of like amount each to the satisfaction of learned Sub-Divisional Judicial Magistrate, Nawada in connection with Govindpur P.S. Case No. 212 of 2018, subject to the conditions as laid down under Section 438 (2) of the Cr.P.C. and with further



conditions --

(i) That one of the bailors shall be a close relative of the petitioner.

(ii) That the petitioner shall not indulge in any similar offence till conclusion of the trial.

(iii) That the petitioner shall remain physically present in court on each and every date during trial and in the event of failure on two consecutive dates without sufficient reason, his bail bond shall be liable to be cancelled by the learned Court concerned.

(iv) That the petitioner shall cooperate with the investigation, if not already concluded, and make himself available as and when so required and in case of failure, the State shall be at liberty to move for cancellation of bail.
