No. 44513 of 2019, in the prayer portion, satisfaction of 'I Additional Sessions Judge, Samastipur', was typed and accordingly while allowing the anticipatory bail by order dated 19.07.2019, it had been directed that the petitioners shall be released on bail on furnishing bail bond and sureties etc.



to the satisfaction of learned Ist Additional Sessions Judge, Samastipur, in Sarairanjan P.S. Case No. 23 of 2019.

It has been stated in the present application seeking modification that the matter is pending before the Additional Chief Judicial Magistrate-VI, Samastipur, and accordingly his satisfaction need to be recorded and the order of this Court dated 19.07.2019, whereby the petitioners have been allowed anticipatory bail, be modified accordingly.
