If a reminder is placed before the C.D.P.O., Naokothi, Begusarai along with a copy of this order, the complaint shall be disposed off, after affording hearing to the parties, by the concerned respondent by passing a reasoned order in accordance with law within the period prescribed under the Guidelines for disposing of such representation/complaint.

4. If the petitioner still remains dissatisfied with the order of the C.D.P.O., Naokothi, Begusarai, she would have the option of challenging such order before the District Programme Officer, Begusarai.

5. The petition stands disposed off as withdrawn with the aforesaid liberty.
