ORAL ORDER

3 02-09-2019 Heard learned counsel for the petitioner and the counsel appearing on behalf of the State.

Petitioner is aggrieved by the order contained in Annexure-1. The District Education Officer, Saran has passed order staying the implementation of grant of senior scale which was extended to the petitioner pursuant to the order passed by this Court in LPA No. 756 of 2015. The SLP against the decision by the LPA Court was dismissed. Notwithstanding, the finality of the decision on dismissal of SLP by the Apex Court and grant of such benefit to the petitioner, the District Programme Officer (Establishment), Saran on the complaint of one Surendra Kumar Singh of Primary Teachers Association stayed the implementation of the decision granting the senior scale to the petitioner. The order dated 25.06.2019 is per se without jurisdiction, as the order was passed by the District Programme Officer (Establishment), Saran without compliance of principles of natural justice. It is now well settled that no order visiting evil and civil consequence can be passed without compliance of principles of natural justice. Admittedly, the order visits evil consequence as the benefit granted to the petitioner has been stayed without compliance of natural justice. It was done only on the complaint made by Surendra Kumar Singh of



Primary Teachers Association. The action of the respondents in staying the implementation of the decision granting senior pay scale is thus, unsustainable as it was taken in violation of principles of natural justice.

Accordingly, Annexure-1 to the writ application is quashed. The consequence of quashing of Annexure-1 will follow with immediate effect.

The writ application is accordingly allowed and disposed of.
