4 16-11-2019 Heard learned counsel for the petitioner and learned
counsel for the State.

The petitioner apprehends his arrest in **Kusheshwar
Asthan P.S. Case No. 06 of 2013**, registered for the offences
punishable under Sections 409, 406, 420, 467 and 468 of the
Indian Penal Code.

It is submitted by learned counsel appearing on behalf
of petitioner that in view of memo no. 1319 dated 22.06.2015
issued by District Education Officer, Darbhanga vide Annexure-
IV, a request has been made to Block Education Officer,
Kusheshwar Asthan (informant) that a criminal case which has
been lodged against this petitioner may be withdrawn, as no



purpose would be served, as the petitioner has already superannuated from the service. Petitioner has got no criminal antecedent.

Considering the facts aforesaid and the fact that petitioner has already retired and the department has come to the conclusion that no purpose would be served by pursuing the case and the fact that petitioner has got clean antecedent, the petitioner above-named, in the event of his arrest/surrender before the court below within a period of six weeks from the date of receipt/production of a copy of this order, is directed to be enlarged on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of the like amount each to the satisfaction of the learned **Sub-Divisional Judicial Magistrate, Darbhanga** in connection with **Kusheshwar Asthan P.S. Case No. 06 of 2013**, subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure with further conditions:-

(i) The petitioner shall co-operate in the trial and shall be properly represented on each and every date fixed by the court and shall remain physically present as directed by the Court and in the event of failure on two consecutive dates without sufficient reasons, his bail bond shall be liable to be



cancelled by the court below.

(ii) If the petitioner tampers with the evidence or the witnesses of the case, in that case, prosecution will be at liberty to move for cancellation of bail of the petitioner.
