5 31-07-2019 Having regard to the fact that opposite parties have passed order on 2.2.2019 whereby claim of the petitioner nos. 1 to 11, 13 to 22 and 28 to 29 has been rejected.

Rest others were found covered by the judgment in C.W.J.C. No. 6139 of 2007 and have been granted the benefit.

Considering the aforesaid, the present proceeding is dropped. The application is disposed of with liberty to the petitioners to challenge the decision dated 2.2.2019 in appropriate forum in accordance with law.
