Considering the aforesaid, the writ petition is disposed of with a direction to the District Programme Officer (Establishment), Kaimur, Bhabhua to verify the record to



ascertain the validity of the appointment of the petitioners and decide the claim of the petitioners for payment of salary at the earliest preferably within a period of 60 days from the date of receipt/production of copy of this order.
